# Webinar - Governance Across the African Pharmaceutical Value Chain

Across the globe, supply chains for health products are complex everywhere. Strong supply chains are essential for effective health care delivery and form the backbone of a country's health system.

The COVID-19 pandemic exposed many countries lacking local capabilities and capacity to manufacture and supply the needed personal protective equipment (PPEs) as well as other essential drugs needed by healthcare workers and the general population to curb the effect of the pandemic. Most countries relied heavily on pharmaceutical and medicine imports due to the lack of local production capacities, policies favoring importation, high cost of importing raw materials and difficulty achieving economies of scale

**Working with partners, the Anadach Group is hosting a webinar to engage key players in Africa to discuss how they can strengthen governance across the healthcare supply chain.** These stakeholders will be representative of various geographies, as well as various key components across the pharmaceutical value chain. ### **Simple, accurate messages on COVID-19 will prevent vaccine hesitancy – Experts**

*Media Coverage on Anadach's Covid-19 Vaccine Hesitancy in Africa Webinar Series*

Experts have urged journalists, social media influencers to ensure that accurate messages on COVID vaccine are disseminated to the public to help prevent vaccine hesitancy.

This was stated at the last of a three-part webinar series held on December 9 with the theme 'COVID-19 vaccine hesitancy in Africa: reimagining the role of key messengers in both traditional and social media and the hospitality industry, as well as within the highly impacted hospitality and services'.

The webinar was co-organised by a global healthcare strategic consulting firm, Anadach Group LLC and a healthcare-focused human capacity development firm, RDAssociates Africa to assist the inoculation of the African population.

One of the speakers, Ms Jolene Samuels, a social media influencer and founder of the 'Jabs Raffles' initiative in South Africa said "I initially hesitated to be vaccinated because of the flood of misinformation and disinformation and doubts over the safety of the vaccines and because there was so much misinformation out there, I did not know what to believe..."

## **Accelerating Nigeria's tuberculosis response on stronger private partnerships**

*Anadach's interview with the BusinessDay newspaper*

For some health sector stakeholders, it is increasingly unsettling to watch how poor response to early detection fuels and sustains the rise in cases of tuberculosis, a "residual pandemic" that kills an estimated 440,000 people each year in Africa's most populated country, Nigeria.

The infectious disease that attacks the lungs, leaving affected patients with mainly severe coughs is preventable and curable. But somehow, Nigeria still ranks high eight countries suffering the highest burden of the disease around the world.

It was on the front line of interest from various support groups and organisations, locally and globally, until the coronavirus pandemic back-benched it, reducing the flow of resources for control in some very vulnerable communities.

Anadach, a health consulting firm has stepped forward to fill these gaps, going after the crucial support that Nigeria's private sector world can contribute to ending the scourge of the disease.

The Nigerian private sector is believed to have a proven record of supporting disease control as demonstrated in the fight against polio, malaria, and even during the latest COVID-19 pandemic outbreak, where the private sector alliance made

significant financial contributions.

Anadach's theory is that by increasing organised private sector awareness and engagement in TB control, staff screening and detection by occupational physicians can be encouraged. It could also promote coverage of TB care services under private sector insurance plans or medical financing.

Egbe Osifo-Dawodu, founding partner of the Anadach Group said a business-as-usual approach will not yield any positive result, giving her assessment of Nigeria's TB situation....

#### **Project Goals**

- Mobilize the organized private sector to support early TB detection, prevention and treatment
- Build capacity for staff screening and detection by occupational physicians

#### **Year One Achievements**

- Advocacy efforts reached over 2 million people in the formal private sector in the TB-LON3 focal states; (virtual & physical) to over 100+ leaders in Lagos, Abeokuta, Ibadan and Oshogbo who represent at least 100,000 employees, in addition to reaching over 2000+ key leaders through our Quarterly newsletter
- Direct Advocacy to over 90 organized private sector stakeholders, focused on getting companies to widen TB screening beyond food handlers to all employees.
- Companies engaged on the project include: Leadway Assurance and its associated Companies, Unilever Plc, Sterling Bank, GT Bank, Dangote Group, OLAM, Animal Care Services Consult, Lafarge Plc, Nigerian Breweries, International Breweries Plc, Sahara Group, GE, Phillips, Honeywell Flour Mills, IHS Towers, Flutterwave.
- Associations engaged include the Nigerian Employers Consultative Association (NECA), State Chapters of the Manufacturers Association of Nigeria (MAN) and Chambers of Commerce and Industry in Lagos and Ogun State.
- Successfully trained 150 Health and Safety Officers, occupational health physicians and human resources for screening and referral of presumptive TB cases.
